<b>FACTS</b>	<b>WHAT DOES GRAVES LIGHT LENHART WEALTH, INC. DO WITH YOUR FINANCIAL INFORMATION?</b>	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership and control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ We have no affiliates.</li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ We do not share with nonaffiliates so that they can market to you.</li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or service to you.</p> <ul style="list-style-type: none"> <li>▪ We do not jointly market.</li> </ul>
Other Important Information	
<p>We also comply with more restrictive state laws to the extent they apply. For example:</p> <ul style="list-style-type: none"> <li>▪ If you are a resident of <b>California</b> or <b>Vermont</b>, we will automatically treat you as though you have elected <b>not</b> to share information outside of the firm except: 1) where such sharing is allowed by law, or 2) where you have contacted us and provided us written authorization to opt you in to such sharing. We will also not obtain consumer credit reports about you without your consent.</li> </ul>
